Participation Rules and Guidelines

All participating groups are required to submit a completed application, which may include any booth fees and refundable deposit. **Applications and fees need to be submitted by May 1, 2015, at 2:00 PM.** Applications submitted afterwards will not be considered. The City of Clermont will make all approval decisions and vendors will be notified. Vendors that are approved for the festival will be assigned a specific location on the event grounds where they can promote their services the day of the event

- Set-up time will be assigned to each organization. In order to keep the set up-process on a timely schedule, organizations must be punctual. Arriving late may result in being unable to access their reserved assigned space by vehicle. Late arrivals may be relocated and required to hand carry their items to their space.
- Electricity will be available in some areas for an additional fee. **Generators are not allowed (food trucks are the only exception)**
- All organizations are required to submit a \$50 refundable deposit when the application is submitted. The deposit is refunded if the assigned area is cleaned and there is no damage to the grounds upon completion of the event. Refunds will be mailed back within three to four weeks after the event.
- There will be no rain date scheduled.
- Vendors may not share or subcontract out their booth with any other vendors.
- Any food vendors must comply with the Florida State Division of Hotels and Restaurant Regulations (See additional form for details.)
- Participating organizations, who do not show up on the day of the event, may not be accepted for future City of Clermont events.
- All vendors must provide their own booth signage, tables, chairs and tents
- Vendor fees are non refundable

The City of Clermont has the right to decline acceptance of any application that they feel does not meet the criteria and parameters set in the mission statement
