Rules and Regulations

- Set-up time starts at 4pm and you *must* be ready by 5:30pm. **You must be set up until 10:15pm.**
- Parking will be provided in nearby vendor parking area.
- Electricity will be available in some areas for an additional fee. Generators are not allowed.
- All organizations are required to submit a \$50 refundable deposit when the application is submitted. The deposit is refunded if the assigned area is cleaned and there is no damage to the grounds upon completion of the event. Refunds will be mailed back within three to four weeks after the event.
- There will be no rain date scheduled.
- Vendors may not share or subcontract out their booth with any other vendors.
- Any food vendors must comply with the Florida State Division of Hotels and Restaurant Regulations.
- Participating organizations, which do not show up on the day of the event, may not be accepted for future City of Clermont events.
- All vendors must provide their own booth signage, tables, water, chairs and tents.
- Vendor fees are non-refundable.
- No multi-level marketing vendors will be allowed. No political campaigns are permitted.
